TERMS AND CONDITIONS

1. The customer shall pay **1673594 Alberta Ltd. O/A "PFD"** for all fuel which passes through the pumps and meters with the volume recorded on the Customer's Receipt and the transaction recording equipment and payment shall be the terms arranged with from time to time. If the customer is in default or payment, **PFD** may close off the sources of the fuel supply to the meters. The Customer shall pay a service charge on overdue accounts as established by **PFD**.
2. The Customer shall pay for all fuel recorded by **PFD** metering equipment designated to the Customer's Account, until **PFD** receives written or verbal notice of the loss or theft of the card(s). Upon loss or theft of the card the Customer shall pay **PFD** the cost of replacement of the card(s) and the cost of reprogramming of the meter for the replacement cards.
3. The price paid by the customer shall be the **PFD** posted price, less discount (if any) to the Customer, in force at the time and place of purchase. Prices for fuel obtained by the Customer shall be subject to increase or decrease by an amount equal to any increase or decrease in **PFD** posted prices, and shall be subject to any applicable tax charges. Any failure by the Customer to meet the terms of this agreement will result in discount being reviewed or cancelled.
4. The Customer shall comply with all applicable laws, government rules and regulations and with all safety, environment and operating procedure of **PFD** as posted at **PFD** facilities.
5. The Customer and Customer's employees will use **PFD** facilities and enter upon the lands entirely at the Customer's own risk.
6. To indemnify and save **PFD** from any and all liabilities of whatever kind and nature for damages to property and loss thereof or for injury or death of any person arising out of or in any way connected with any act of omission of the Customer or Customer's employees in or about **PFD** facilities, or in operation of the facilities thereon or in the exercise of any right or obligation under this agreement.
7. The Customer shall obtain and keep in force during the term of this agreement motor vehicle liability insurance covering all motor vehicle used in connection with operations under this agreement with inclusive limits or not less than the minimum amount as may be required by provincial or federal legislation.
8. This agreement can not be assigned without **PFD's** written consent.
9. Neither party shall be liable in damages or otherwise nor shall this agreement be cancelled for failure to carry out the terms of this agreement in whole or in part where caused directly or indirectly by or in consequence of exercise government or other authority whether pretend or real, fire, storm, flood, war, rebellion, insurrection, riot, civil commotion, strikes, difference with workmen or others, failure of carries to transport or furnish facilities for transportations or distribution, commitments of **PFD** to others or by a cause whatsoever beyond the control of **PFD** whether similar to or dissimilar from the cause enumerated herein.
10. In the event that any of the provisions of this agreement are breached by either the Customer or **PFD**, notice of such breach shall be given to the party and if not remedied within 15 days then this agreement shall terminate, provided the Customer shall pay **PFD** personally for all fuel supplied here under and up to and including that date.
11. This agreement cancels all previous card access Customer agreements between **PFD** and the Customer. I (we) will waive any time limitations under the Limitations Act and/or other statutes in this Province in the collection of this account.
12. If **PFD** should have to initiate a collection process against the Customer, a 10% collection fee will be added to the outstanding balance of the Customer's account at the time of a minimum balance of a \$100.00.
